# 02 Step-by-Step Registration Process.

Step	Action	Time
1	Company name approval.	2-4 days
2	Corporate document preparation, Memorandum and Articles of Association in both Greek and English, appointment of first director and secretary, and other documents.	1-2 days
3	Document signing, lawyer certification and submission to the registrar.	1-3 days
4	Receive Certificate of Incorporation and other certificates from the Registrar of Companies.	8-10 days
5	Registration with the Cyprus Tax Department.	5-10 days
6	VAT registration and other registrations, if applicable.	2-3 weeks
7	Corporate bank account opening.	From 2 weeks



# Documents

## 03 Required Documents.



**01. Passport Copy.** Original presented in person or apostilled/notary-certified.



**02. Proof of Residential Address.** Original presented in person or apostilled/notary-certified.



**03. Identity Verification Link** (Optional Alternative for both **01.** and **02.**) Can replace notarised/apostilled passport and address documents through our secure digital verification platform.




**04. Bank or Professional Reference Letter.** Original or apostilled/notary-certified.



**05. CV (Curriculum Vitae):** Summary of education, experience, and skills.



**06. Proof of source of funds/wealth.** We provide guidance based on each individual case, but generally request bank statements, recent tax returns, proof of company ownership, and similar supporting documents.

## 05 Post-Registration Obligations.

- Maintain a registered office/address and company secretary in Cyprus.
- File annual return, yearly minutes for the Annual General Meeting, and annual UBO register declaration.
- Prepare accounting records and audited financial statements.
- Preparation of VAT returns- if applicable.
- Preparation of VIES returns- if applicable.



## 06 Frequently Asked Questions.

How long does it take to register a company in Cyprus?

Typically, 8-10 working days after client KYC is approved, payment is received, and the company name is approved, signed corporate documents are delivered in our Cyprus office.

Can foreigners own 100% of a Cyprus company?

Yes, foreign individuals or entities can fully own a Cyprus-registered company.

Do I need to visit Cyprus to register a company?

No, registration can be completed remotely through a licensed administrative service provider.

What is the minimum share capital?

No minimum legal requirement, but a €1,000 share capital is standard.
